1. Welcome note by the Chairman-IQAC

The meeting started with the warm welcome to all the members by the Chairman-IQAC Dr.D.R.Somashekar. He then requested Coordinator-IQAC, Dr.Sanjeev Goyal to proceed.

Dr. Sanjeev Goyal thanked the chair and started to elaborate the agenda point wise.

2. Review of the Previous Meeting (14-02-2020)

Dr.Sanjeev Goyal (IQAC Coordinator) told that, in the last meeting of IQAC held on 14-02-2020, the 'Audit Reports' of the audit of all the departments for odd semester 2019-20 were presented and elaborated in detail. Heads of the departments were asked by the Director to go through the reports and work on the suggestions given to overcome the deficiencies.

HODs demanded the copy of the report signed by the auditors, which agreed upon and were sent to them by the Coordinator IQAC.

3. Action Taken by the Departments

HODs of CSE, IT, ECE, EN, ME, Civil, AS&H and MBA narrated the actions taken by their respective departments on the suggestions in the audit reports. They told that many of the suggestions couldn't be implemented due to the lockdown. They said that now they have started working on the suggestions'.

HODs were requested by the coordinator to submit within a week, the written action against the suggestions in the audit reports.

HOD IT Mr. V.K.Tripathi requested the Coordinator IQAC that it would be convenient to the departments going for audit if they are informed in advance about the files and documents required at the time of audit.

4. Feeback on Online Sessional Examinations

All the HODs told that during the lockdown period, sessional examinations were conducted online without any difficulty using the Institute's Software (LMS), Google Meet etc. They expressed their satisfaction on the strength of the students in the online examinations.



5. Feeback on Online Classes

HODs told that in order to avoid academic loss due to lockdown, they started the online classes using the Institute's Software (LMS), Google Meet, Zoom etc. Faculty members took their classes as per the time table issued to them by the departments. Students were taught by sharing the notes and video lectures. Almost all the students and their parents expressed their satisfaction on this mode of classes. A few students had internet connectivity problem in their areas, however such students completed the syllabus using the soft notes and videos given to them.

HODs told that in addition to online theory classes their departments will also start online labs in the coming session.

6. Preparation of Soft Notes, PPTs and Video Lectures

Heads of the departments told that the faculty members are preparing soft notes, PPTs (wherever needed) and video lectures to be used for the online classes in the upcoming session. All the materials being prepared for the online classes will remain available in the respective departments.

7. Maintenance of the Attendance Record

Coordinator-IQAC told the HODs that from the coming session (2020-21), attendance record of the students attending the online classes is to be maintained in the 'Attendance Register' as well as on the college 'ERP'. To which HODs agreed readily.

8. Conduction of FDPs/Webinars for faculty & Students

HODs were advised by the Director Dr. D.R. Somashekar that they should organize more online FDPs, webinars etc for the benefit to not only faculty members but also to the students. HODs CSE, IT, ECE, EN, ME and MBA told that their departments have already conducted either online webinar(s) or FDP(s) or both, whereas the HOD Civil and HOD AS&H told that they are planning to conduct FDP and/or webinar very soon.



9. Online e-Certificate Courses by the Faculty Members

HODs told that all the faculty members of their departments are attending online FDPs, Webinars etc and getting the e-Certificates. In addition to this a few faculty members have done or doing the NPTEL courses too.

Director RKGIT Dr. D. R. Somashekar and Director CRC Dr. Dilip Moza discussed about the status of placement of the students (passing out 2019-20) in various companies.

Meeting ended with vote of thanks by Dr. Sanjeev Goyal.
