### 1. Welcome Note

The meeting started with the warm welcome to all the members by the Coordinator-IQAC Dr. Sanjeev Goyal. He then requested Director to preside the meeting.

Director Dr. D.R. Somashekar welcomed all the members and asked Dr. Sanjeev Goyal to proceed.

Dr. Sanjeev Goyal thanked the chair and started to elaborate the remaining agenda point wise.

### 2. Review of the Previous Meeting (12-04-2022)

Dr. Sanjeev Goyal (IQAC-Coordinator) told that, in the last meeting of IQAC which was held on 12-04-2022:

- The agenda of the 12th meeting of IQAC held on 01-04-2022 was taken up again for comprehensive discussion.
- Deficiencies observed during the audit of the departments for even semester 2020-21 were discussed with the individual HOD by Prof. Laxman Prasad (group advisor). Director Dr. D.R. Somashekar requested the HODs to submit the compliance reports on or before April 18, 2022.

(Action: Compliance reports were submitted by the HODs to the Coordinator-IQAC)

 Academic Policy for the session 2022-23 was proposed by Dr. Sanjeev Goyal. Director invited suggestions from the IQAC members. Suggestions were given and discussed in detail. Director requested the coordinator to prepare the draft of the academic policy 2022-23 after incorporating all the suggestions.

(Action: Draft of academic policy 2022-23 is being prepared and will be circulated to the members well before the  $14^{th}$  meeting of IQAC.)

### 3. Academic Policy 2022-23

- Following suggestion were given by the members and were accepted for the inclusion in the academic policy 2022-23.
- Record of first year students is to be maintained by the Registrar, whereas 2<sup>nd</sup> year onward the record of the students is to be maintained by the respective HODs. The lists signed by the Registrar or HODs as the case may be, will be made available to all the offices.
- Faculty for counseling the students will be known as counselor in first year and as mentor for the students 2<sup>nd</sup> year onward.
- Identity card is compulsory in the campus for the faculty, staff and the students.
- Colour of strips of the identity cards has to be different for the students pursuing different programs.
- Central library of the institute has to go for the stock verification after the completion of each academic session.
- Mention of ERP system should also be there in the academic policy.

- PTM can also be held online.
- Budget of the departments should also be included in the academic policy.

### 4. Review of the Existing R & D Policy

Existing Research & Development policy of the institute was discussed in detail. Director invited the suggestions from the members present.

Suggestions given are as follows:

- (i) In the R & D policy the incentive amount for the research publication must also be for the co-authors too instead of only to first author.
- (ii) The incentive amount for the research publication be increased from Rs. 3000/- to Rs. 5000/- for the publications in Scopus and from Rs. 5000/- to Rs. 10000/- for the publications in the SCI journal.
- (iii) The requirement of impact factor-2 to claim the incentive for the research publication must be waived off.

Director Dr. D. R. Somashekar told that in case of sole author who belongs to RKGIT, the total incentive amount will be given only to the sole author. However, if there are more than one author then the incentive amount will be distributed equally and given only to the author (s) belonging to RKGIT. Same was endorsed by Prof. Laxman Prasad.

In respect of the Patent filing, publication and grant Prof. Laxman Prasad suggested the following incentive policy:

- (i) In case of provisional patent application filed in the name of RKGIT, the initial processing fees will be paid by the institute.
- (ii) The incentive of Rs.10000/- will be paid to the inventor on the grant of the patent. The expenditures towards maintenance of the patent will be equally borne by the institute and the inventor.
- (iii) In case when the patent is commercialized the revenue accrued shall be shared among the inventors and RKGIT as per mutual agreement.

In addition to the above Prof. Laxman Prasad proposed a number of amendments in the existing R & D policy. Director requested coordinator to incorporate all the proposed changes in the R & D policy.

### 5. Review of the Leave Rules

The existing 'leave rules' of the institute which came in to force w.e.f. July 01, 2016 were reviewed. It was reaffirmed by Prof. Laxman Prasad that the casual leave can not be combined with any kind of leave except with holidays and Sundays.

### 6. Academic Audit Odd Semester 2021-22

As discussed the academic audit of all the departments has started from 18<sup>th</sup> April 2022 and will be completed by 21<sup>st</sup> April, 2022.

Coordinator needs to convey to the internal auditors to do the audit focusing on the qualitative aspects.

### 7. Examination Reforms

It was decided that

- (1) A scrutiny committee will be formed by the C.O.E. for the random scrutiny of the evaluated answer scripts of ST-1, ST-2 and PUT exams.
- (2) All faculties including HODs will do the invigilation as well as evaluation work.

Meeting concluded with the vote of thanks by the coordinator Dr. Sanjeev Goyal.


